- *Dogs: DAPP and Rabies every other year and Bordetella every 6 months
- *Cats: Rabies (yearly to every other year dependent on vaccine type), FVRCP every other year
- *Cats: Indoor cats are required to have a negative FeLV/FIV test on record. Any cat not 100% indoors must have a FeLV/FIV test yearly
- *Proof of negative Intestinal Parasite Exam within the 6 months prior to boarding (This is not only for your pet's protection, but also for the protection of our other guests)
